



KANO STATE SUPPLEMENTARY APPROPRIATION LAW 2020 (1442 A.H.)

WHEREAS the Kano State Appropriation (Amendment) Law 2020 (1442 A.H) was duly assented to by the State Governor in compliance with the provision of section 121(4) (a) and (b) of the Constitution of the Federal Republic of Nigeria 1999 (as amended).

AND WHEREAS a need has arisen for expenditure for a purpose for which no amount has been appropriated by the law.

AND WHEREAS it has become imperative that review of the current estimates be made in order to provide for expenditures not earlier catered for by the 2020 Appropriation (Amendment) Law;

AND WHEREAS in compliance with the said constitutional provisions the Governor of the state has laid before the State House of Assembly the Supplementary Estimates showing the sums required and the Head of expenditure in respect of the estimates.

NOW THEREFORE IT IS HEREBY ENACTED by the Kano State House of Assembly as follows: -

Citation and Commencement

1. This Law may be cited as the Kano State Supplementary Appropriation Law, 2020 (1442 A.H.) and shall be deemed to have come into operation on^{23rd} day of.....^{Dec.}.....2020(1442 A.H.)

Issues and appropriation of N52,199,013,705

2(1) The Accountant General of Kano State may when authorized to do so by warrant signed as authorized by section 120(2) of the Constitution of the Federal Republic of Nigeria 1999 (as amended) issue from the Consolidated Revenue Fund of the State during the year ending on 31st December, 2020 the sum specified by the warrants not exceeding in the aggregate of **N52,199,013,705 (Fifty Two Billion, One Hundred and Ninety-Nine Million, Thirteen Thousand, Seven Hundred and Five Naira Only)** being the total amount set forth opposite Codes 011100000000 to 055811200000 in the schedule to this Law.

(2) The said sum shall be appropriated for the purpose and in the manner expressed in the Schedule.

3. The monies granted by this Law are provided for the services in respect of which monies will become payable within the year ending 31st December, 2020 and any lapse shall not be available for making any payment in any subsequent month.


